



SEN Information Report September 2016

These pages set out information about our provision for children and young people with special educational needs (SEN). They are updated annually.

About our school

Dunmore Primary School provides for children and young people with a wide range of special educational needs including those with:

- Communication and Interaction needs; this includes children who have speech, language and communication difficulties including autistic spectrum conditions.
- Cognition and Learning needs; this includes children who have learning difficulties and specific learning difficulties like dyslexia, dyspraxia and dyscalculia.
- Social, Emotional and Mental Health needs
- Sensory and/or Physical needs; this includes children who have visual or hearing needs, or a physical disability that affects their learning

We are a mainstream school catering for up to 490 children. Currently the school has 454 pupils with 12.5% (57 children) of those with special needs.

The person who co-ordinates special needs in the school is called the Inclusion Manager and her name is Vicky Leeds. She can be contacted by telephone on 01235 520550. Our governor with responsibility for SEN is Mrs Pollard.

How do we identify and give extra help to children and young people with SEN?

The school uses Oxfordshire County Council's guidance 'Identifying and supporting Special Educational Needs in Oxfordshire schools and settings'. The guidance sets out:

- How we identify if a child or young person has a special educational need.
- How we assess children and plan for their special educational needs, and how we adapt our teaching.
- Ways in which we can adapt our school environment to meet each child's needs
- How we review progress and agree outcomes and involve you and your child in this.

How do we work with parents and children/young people?

We will always contact parents if we have a concern that a child or young person may have a special educational need. We work closely with children and young people with SEN and their parents to agree outcomes and how we will all work towards these, and then to review progress. We do this: by termly meetings, in line with parent evening meetings, using home/school diary, scheduled phone calls etc

We welcome feedback from parents and children relating to the schools SEN policy. Please do this by contacting the school office.

Adapting the curriculum

We offer a broad and balanced curriculum for all children and young people including those with SEN. Details are published on the school website. The way we adapt this for children with SEN and disabled children is set out in our relevant policies. We use a range of intervention programmes to support the development of literacy and numeracy skills. Nurture groups are used to support children with SEMH needs where needed. We have a member of staff who has completed ELSA training (Emotional Literacy Support Assistant) and will begin to support children throughout the school.

What expertise can we offer?

Our Inclusion Manager has over 6 years of teaching experience supporting children who have SEN within her class, has completed a Middle Leader Course and is currently completing the National Award in SEN co-ordination. All staff have basic awareness level training in teaching pupils with SEN. Some staff have received enhanced training in certain areas or have trained at a specialist level. Many Teaching assistants are trained to support the particular needs of the children they work with.

Our SEN governor is Mrs Faye Pollard.

We also have access to a range of specialist support services including

- Educational Psychology
- SENSS, who support children with communication and language, sensory needs and physical needs
- Behaviour Support
- Child and Adolescent Mental Health Services (CAMHS)
- Oxfordshire School Inclusion Team
- Therapy services including Occupational Therapy and Speech and Language Therapy.
- Early Intervention
- Children's Social Care

We always discuss the involvement of specialist SEN services with parents first. We also work with other services and organisations that are involved with a family, with the family's permission.

How do we know if SEN provision is effective?

The progress of all children/young people is tracked throughout the school through a range of Teacher assessments, tests, focussed work, observations and discussions.

In addition for children/young people with SEN we regularly review progress towards agreed outcomes assessing whether the support that's been in place has made a difference and what we need to do next. We evaluate this progress against age related expectations. Each child with SEN has an individual Pupil Tracker which records support/ interventions received and their impact.

When we run special intervention programmes for groups of children we assess how successful they have been and use that information to decide on how best to run them in the future.

Information about how the governing body evaluate the success of the education that is provided for pupils with SEN is contained in the governors' annual SEN report.

How are children and young people with SEN helped to access activities outside of the classroom?

All children and young people are included in activities and trips following risk assessments where needed and in accordance with duties under the Equalities Act 2010. We talk to parents and young people when planning trips so that everyone is clear about what will happen.

What do we do to support the wellbeing of children/young people with SEN?

All children have the opportunity to share their views through their school council representatives.

We gather and listen to the views of children/young people with SEN regularly via the school council representatives and pupil questionnaires.

We take bullying very seriously. We help to prevent the bullying of children/young people with SEN by all class teachers recording in a behaviour log any incidents deemed unkind or bullying in nature and these are dealt with swiftly. The behaviour logs are monitored closely by the Head teacher throughout the year.

Joining the school and moving on

We encourage all new children to visit the school before starting. For children/young people with SEN we will meet with parents and children, gather information from previous schools and agencies and where possible ensure the correct level of support is put in place as soon as practicable.

We begin to prepare young people for transition into the next stage of their education or training by extra visits, meeting relevant adults, taking photos and making books of the new environment, completing transition books and ensuring all relevant information about the children is passed on to the future educators.

Who to contact

If you are concerned about your child then the first port of call will always be your child's teacher.
